The proposed FID is located along Jolly Road, between Hagadorn and Okemos Roads, on the border of Meridian and Alaiedon townships. This district has significant potential to serve as a nexus of regional growth for agriculture businesses, food processing, storage and distribution in mid-Michigan. It presently is home to several food-related companies. Also located within is an MSU-owned building proposed to house MSU's Food Processing Innovation Center, a food business accelerator currently in its planning phase.
