

The University of Eastern Finland (UEF) is one of the largest universities in Finland. The UEF is a multidisciplinary university, which offers teaching in more than 100 major subjects. The university has approximately 15,000 students and some 2,800 members of staff, and the university's campuses are located in Joensuu, Kuopio and Savonlinna.

The University of Eastern Finland is inviting applications for the following position (**extended application period**):

Senior Lecturer (International Business), fixed-term position, Business School, Kuopio Campus

The University of Eastern Finland offers education in economics and business administration at the Bachelor's, Master's and doctoral levels. One of the themes of research and teaching of the Business School at the Kuopio Campus is international business and sales management.

The duties of the Senior Lecturer involve research and teaching at the Bachelor's, Master's and doctoral levels in the field of international business relating to business internationalisation, management of international business, international networking, and creation of global brands. The language of instruction is English. The duties of the Senior Lecturer also involve the supervision of final theses. The Senior Lecturer is expected to participate in the development of research and education in the field of international business and sales management, as well as in the preparation of research and development projects.

In accordance with the university's Administrative Regulations (Section 30), persons to be appointed as Senior Lecturers shall hold a suitable doctoral degree and have good teaching skills.

The person to be appointed is expected to hold a doctoral degree in the field of international business, international marketing or some other applicable field. Furthermore, the person to be appointed is expected to be a specialist in international business both in research and teaching. Pedagogical training and experience in working in projects will be regarded as merits.

The language requirements associated with the position are defined in the Government Decree 770/2009. Members of the university's teaching and research staff are required to have command of the language they give teaching in (Finnish or Swedish). The Dean of the faculty may grant an exemption from the language proficiency requirements laid down in the Government Decree.

The position is filled for a fixed term of three years beginning on 1 May 2014 or as agreed. The position is filled for a fixed term due to it being associated with the launch of an international Master's degree programme.

The salary of the position is based on levels 5–7 of the job requirement level chart for teaching and research staff (€2,820.64–€3,799.56/ month). In addition to the job requirement component, the salary is supplemented by a personal performance component, which can be a maximum of 46.3% of the job requirement component.
