- 3. The recommended length of an article is 5,000 to 6,000 words inclusive of all notes, references, tables and appendices.
- 4. All articles should be accompanied by an abstract (100 to 150 words) and 3-4 key words.
- 5. Articles should be prepared and submitted in text format (MS-Word) using Times New Roman font of 12 size, and A4 format with 1.5 line spacing. Please note that PDF versions are not accepted.
- 6. Authors are requested to follow the APA (American Psychological Association) style of referencing.
