The EURAM's Corporate Governance SIG focuses on research exploring the antecedents, characteristics, processes and consequences of corporate governance in organisations. It is particularly interested in topics related to Corporate Governance systems, Boards of Directors and Top Management Teams.

This workshop is aimed to help researchers, interested on these topics, to improve their papers in order to increase their chances to get published in top journals. With the collaboration of three of the most highly recognised journals in the COGO field, the workshop offers the opportunity to closely interact with editors of high-impact journals, and get direct and specific feedback that will help authors to further develop their papers and target top journals.

We encourage authors wishing to publish in top journals, especially those whose native language is not English, to submit their papers to the workshop and work jointly with our experts to increase their chances to deal successfully with the reviewing process of high-impact journals. All editors participating in the workshop will provide customised advice to the authors of a maximum of 4 papers (two per parallel session).
