1) Individual proposals that consist of

- Title
- Theme(s) addressed
- Contact information
- An abstract of your paper consisting of no more than 500 words (2 pages)
- An updated CV

2) Panel sessions of 3-5 participants that consist of

- Proposed title of the panel session
- Theme(s) addressed
- A 500 word (2 pages) overview of the main theme(s) discussed in the panel and how each paper interconnects
- Full contact information of each participant
- Updated CVs for participants

The conference encourages proposals from current and emerging scholars, those in public policy and industry partners. You will be notified electronically of your acceptance no later than 16 May 2016.

Presenters whose proposals are accepted for the conference will be invited to submit full papers of no more than 20-25 pages on the topic outlined in your abstract. The best paper selected by the conference committee will win the Best Paper Award.
