- 3) Traditional Ecological Knowledge (TEK) collection and transcription. #### Introduction

Inland fisheries section of GLIFWC will be interviewing candidates for two intern positions for summer 2018. Successful candidates will be integrated into several fisheries projects occurring in the Ceded Territories in partnership with state, federal, and tribal agencies. Specifically, interns will be assisting with an acoustic telemetry project on Mille Lacs Lake, mark/recapture study also on Mille Lacs Lake, data analysis of a walleye diet study, and data collection for a comparative walleye recruitment study on several lakes throughout Wisconsin. Please see tentative schedule below.

### **Work Plan**

May 14<sup>th</sup>- June 1<sup>st</sup>. Telemetry project on Mille Lacs Lake. Deploy acoustic receivers, temperature and light sensors in several habitats and depths in the Northern part of the lake. Catch and surgically implant acoustic transmitters into juvenile and adult walleye in this location.

June  $2^{nd}$  – June  $30^{th}$ . Orientation and first aid training, juvenile walleye assessment and mark/recapture study on Mille Lacs Lake. Work with state and tribal biologists to estimate the population of adult walleye and relative abundance of juvenile walleye.

July 1<sup>st</sup> – July 13<sup>th</sup>. Comparative walleye recruitment study. Collect abiotic (e.g., temperature) and biotic (e.g., fish community) information on several lakes throughout the Ceded Territories in Wisconsin. This information will help fisheries managers identify variables that might be leading to good and poor recruitment of walleye.

July 14<sup>th</sup> – July 22<sup>nd</sup>. Data analysis of walleye diet study. Create graphs and descriptive statistics that summarize the data on a two-year diet study on Lac Vieux Desert and Sherman Lake. Update CV and build presentation/poster for meeting at Sandy Lake

July  $23^{rd}$  – July  $29^{th}$ . Sandy Lake Ceremony and meetings. Present on summer projects to GLIFWC board and Voigt Intertribal Task Force.

July 30<sup>th</sup> – August 12<sup>th</sup>. Comparative walleye recruitment study. Repeat data collection on lakes sampled in July.

The specific topic involved will depend on particular legal or policy issues requiring analysis. Examples may include analysis of water diversion application requirements under an interstate compact, drafting testimony to a state legislature on pending legislation, or researching and analyzing changes in state law and their potential impacts on treaty harvesting. The goal of this project is to support the Tribes' rights to sovereignty in the area of off-reservation treaty reserved rights. The exercise of these rights is critical to ensuring that future generations will be able to carry out traditional economic and cultural activities as intended by the Ojibwe signers of the treaties. The intern will be responsible to complete reading, research and writing projects as assigned by the Division of Intergovernmental Affairs.

We will prioritize candidates who have completed their second or third year in college, instituting a preference for tribal members and Native Americans. We intend to work with other divisions to provide the interns opportunities to learn about GLIFWC, meet with tribal representatives, partake gathering activities and birchbark canoe building, and visit with tribal members to give the interns a full picture of the communities, which will likely lead to better legal analysis.

**POSITION:** Forest Structure for martens Interns (2)

Work will take place at the GLIFWC satellite office located at the Land Information and Computer Graphics Facility (LICGF) on the University of Wisconsin Madison campus. GLIFWC will provide all hardware, software and training necessary to complete the tasks.

The intern will also participate in GLIFWC orientation and training during the first week of the internship. Other activities scattered throughout the internship are the annual healing circle run, canoe building, Sandy Lake memorial ceremony, Board of Commissioners meeting, and preparing a scientific poster to present at the Voigt Intertribal Task Force and Board of Commissioners.
