### **Position: Seasonal Wildlife Technician (Temp.- Natural Resources Department) – (2)**

**Summary:** This seasonal position will be assist the wildlife program with fieldwork. This position will include extensive fieldwork, equipment upkeep, extensive driving, technical reports, and some data analysis. This position requires flexibility in scheduling which includes late nights and possibly weekends. **Note:** The position is temporary, full-time not to exceed 89 days worked.
