

BOONE AND CROCKETT CONSERVATION INTERN

This temporary intern position will help plan, prepare, market and conduct conservation education activities in line with the vision, mission and objectives of the Boone and Crockett Club and the Club's Conservation Education Program. Work will be conducted at the Elmer E. Rasmuson Wildlife Conservation Center (RWCC) on the Boone and Crockett Club's Theodore Roosevelt Memorial Ranch (TRMR) west of Dupuyer, Montana.

DUTIES, FUNCTIONS AND RESPONSIBILITIES:

The position is responsible for the following, but are not limited to:

- Ensure conservation education programs are focused primarily on ecology of the Rocky Mountain Front, ethical fair chase hunting, natural resource conservation, and shared, sustainable, and ethical management and use of Montana's wildlife and their habitats with specific focus on the coexistence of livestock and wildlife on the TRMR.
- Development and preparation of all educational curricular materials to be used with students and adults onsite and online. Education/Outreach experience and interest, especially in K-12, is preferred but not required.
- Maintaining ongoing social media, website and social media pages. Other areas of focus may include business development, educational content development, maintenance and repair type work, hospitality and outdoor recreation instruction with youth. Friendly and personable people skills required. Applicant will be encouraged to communicate with Boone and Crockett Staff as well as University Internship Coordinators in order to better facilitate where and how they feel they will best serve the needs of the RWCC and its programs. (Business development, marketing and all other areas of emphasis are welcome!)
- The primary workplace environment is located on a remote, rural cattle ranch. The TRM Ranch is located in the heart of grizzly bear country and is home to a diverse amount of wildlife. Applicants must be comfortable around animals both domestic and wild.
- Applicants may be needed to operate manual transmission vehicles, tow trailers, operate ATV's and will carry bear deterrent pepper spray. CPR and First Aid certifications are recommended prior to start date. Knowledge of or ability to acquire skills in safe firearms handling and operation, big game hunting, wildlife and plant identification, wilderness skills and ethics as well as any other outdoor and natural resource conservation skills (i.e. fly-fishing, hiking, camping, bird-watching, astronomy, etc.) are highly recommended.
- Approximate start date of June 1, 2020. Approximate end date of August 21, 2020. Dates are flexible.
