2021 Conference Special Features

This will be the 20th Year a conference has been held, although the first in virtual space.

Zoom platform will be used for virtual presentations and collaboration. Communal sessions will be scheduled for sharing, discussion of possible collaboration, and exploration and development of mutual interests.

Sessions will be planned over a five-day schedule for a few hours a day. Program schedule will be flexible; accommodations will be made for all time zones to schedule convenient sessions as needed and possible.

Submission Guidelines

Submissions of full papers and extended abstracts is welcome through the conference website. All submissions are subject to double-blind peer review process.

You are invited to submit either an Extended Abstract or a Full Paper (of research nature or a teaching case) for presentation at the conference.

Extended abstracts: A submission should explicitly contain: 1. Background & Problem Statement; 2. Objectives; 3. Methods/Procedures; 4. [Expected or Preliminary] Results; and 5. References. Extended abstracts between 3 to 5 pages are preferred.

Full papers: No specific structure is required for complete papers. We strongly recommend complete papers not to exceed 12 pages. Quantitative Papers should include full data analysis.

Formatting guidelines for either extended abstracts or complete papers in MS Word format are provided on the conference website, LaTeX proceedings template is also available. All submissions should be written in English. All submissions are peer reviewed, acceptance being based on quality and relevance. Plagiarism is unacceptable. All authors must fully cite the work of others using one of the standard citation systems (either APA, or MLA).

Submissions should be done via the conference web site. By submitting a paper or an extended abstract, authors acknowledge their intention to participate in the virtual conference through Zoom allowing presentation during session to be recorded.

Authors of accepted proposals will have up to 30 minutes (Q&A included) to present their topic in the conference.

Accepted full papers and extended abstracts presented in the conference will be published online, at the discretion of authors, in the Social Science Research Network (Congress, ISSN 1537-2316). Proceedings will be published after the conference. Authors retain copyright of their works. The conference proceedings will be Scopus indexed as soon as our application is approved.

Registration Fee:

- presenting author (academician or professional) - **100 USD**

- student presenter; co-author or author presenting each additional paper, other participants such as non-presenting authors, non-presenting students, guests, observers - **50 USD**

There is a reduced fee structure for 2021 virtual conferences; fees are determined to cover operating expenses only. Any registration fee includes annual membership fee worth 25 USD (non-refundable). For each accepted paper, at least one author needs to pay one full registration fee by November 15th, 2020 at the latest to be scheduled for the conference presentation. Various payment options are provided on the conference website (bank card preferred, check, wire transfer)

IBEC is a non-profit organization registered in the USA, State of Tennessee. Members and participants are scholars from around the world interested in genuine scholarship in business disciplines related to international business and economies. The organization is directed by a conference chair who serves a three-year term, an assistant chair, a program committee composed of former chairs, and an editorial board composed of established scholars. We encourage new participants and interested scholars to work together with us and each other, learn from each other and define new ways for achieving true scholarship by utilizing new technologies and exchanging best practices.
