## LECTURER or CLINICAL PROFESSOR POSITIONS IN INTERNATIONAL BUSINESS (2)

The Institute of International Business in the J. Mack Robinson College of Business (RCB) invites applicants for two (2) non-tenure track positions at the rank of Lecturer, Senior Lecturer or Clinical professor (9-month appointment). Lecturers are eligible for promotion to Senior Lecturer within Georgia State University and manage a 4-4 teaching load. Clinical Assistant Professors normally have a 3-3 teaching load. Final rank is contingent upon experience and qualifications. The successful applicant will join a department of faculty and staff who are committed to innovative teaching; diverse, equitable, and inclusive excellence; and interdisciplinary collaboration.

Applicants should have expertise in supporting the University's and RCB's strategic goal of becoming a national model demonstrating that students from all backgrounds can imagine and develop solutions to problems and innovative new products and services that create value for themselves, their communities, and the society. Successful candidates will help oversee and expand curricular offerings, interdisciplinary partnerships, and integration of curricular and non-curricular experiences at the graduate and undergraduate levels.

**Georgia State University.** GSU is the largest university in Georgia with more than 53,000 students enrolled. Georgia State University continues to lead the state and nation in graduating economically and racially diverse students on-time and at a reasonable cost. The university enrolls more than 21,000 African Americans, 13,500 White, 6,000 Asian, 5,600 Hispanic, and 3,000 Multiracial students each semester. Pell-eligible students, many of whom are first-generation college students, currently represent 58% of the University's undergraduate student population, ranking first among all national universities in the percent of Pell students that it enrolls.

Recently, Georgia State University became the first institution in U.S. history to award more than 2,000 bachelor's degrees to African American students in a single year -- more than any other non-profit college or university in the United States. Georgia State's diversity is truly exceptional. According to *U.S. News and World Report*, Georgia State University is one of only two universities to rank in the Top 15 in the nation for both its racial/ethnic diversity and the percent of low-income students enrolled. Georgia State has eliminated achievement gaps based on race, ethnicity or income. As a result of these efforts, in May 2018, *The New York Times* ran a feature article on Georgia State, calling the institution "an engine of social mobility." Additionally, *U.S. News and World Report* ranks Georgia State as the 3rd *Most Innovative Institution in the Country*.

Georgia State is a leading research university ranking 78<sup>th</sup> out of 408 public universities in the U.S. for research expenditures according to the National Science Foundation. In FY 2020, Georgia State faculty earned a record \$150.2 million in external research funding, the sixth consecutive year that funding exceeded \$100 million.

**Qualifications:** Applicants must have an earned Doctorate in Business, Management, Communication or a related field from an accredited university or international equivalent. Candidates for this position should demonstrate a record of outstanding university-level teaching. Preferred candidates will have: teaching experience in other countries; professional experience in business, communications, or related fields; expertise in diversity, equity and inclusion; as well as have a record of active membership in relevant professional organizations.

**Responsibilities:** Primary responsibilities include teaching undergraduate and graduate international business and communication courses and fostering relationships with internal and external stakeholders. Other responsibilities include unit and college committee-based service, including student advising and club advisement.

**Appointment:** These 9-month non-tenure track positions begin in August 2021.
