Community-Based Data Collection/Evaluation Technician (Seeking 1 student for this position)

Seeking student that can apply public and community health data collection methods and analysis as well as evaluation practices to help with the development, implementation, and evaluation of a community-based nutrition intervention, including a marketing campaign

The responsibilities would include:

- Collecting data using surveys, 1:1 interviews, and other evaluation tools to measure the intervention
- Analyzing multi-level data points and reporting out on findings
- Evaluating components of a health communication and marketing campaign
- Recording meeting minutes and incentive distribution

Skills you would have OR want to further develop:

1. Capacity to use SPSS and Atlas to analyze quantitative and qualitative data.
2. Capacity to work with community members and local grocers to strengthen and organize for food sovereignty.
3. Capacity to work effectively, efficiently, and constructively with your mentor and the coalition members.
4. Capacity to produce reports that highlight the project's efforts to advance health and health equity.

Qualifications

- Currently enrolled student at a Lansing-based college or university that is or has the intention of studying health, healthcare, psychology, exercise science, public health, community health, statistics, or public policy and can demonstrate they have lived or worked in Lansing. Students in a bachelor's program or enrolled or actively engaged in a graduate program are preferred.
- Willing to work flexible days and hours (early morning, evening and weekend hours will be required)
- Reliable transportation and ability to travel (local/regional travel required)
 - o *Proof of valid driver's license and car insurance is required*

You might be interested in this position if you are passionate about public health, nutrition policy and community-based participatory research, food systems, and food justice. This project will demonstrate the value of a multi-level community-health intervention that advances policies, systems, and environments.

Key Points to Consider when applying:

- Positions will be filled ASAP on a rolling basis and will have an approximate start date of August 16, 2021.
- Positions will require approximately 15-20 hours per week.
- If there is mutual interest between WSU and the student, opportunities to continue work on this evaluation or other projects in 2021 are available.
- Compensation will be at a competitive hourly rate, plus reimbursement for mileage at the government rate, \$0.545/mile
 - o *Data collectors will be required to invoice for their travel expenses on the final day of each month; payment will be dispersed within 14 business days.*
 - o *Students eligible for payment will complete a timesheet via Academica every two weeks.*
