

# Mason-Lake Conservation District Vacancy Announcement Field Crew - Hemlock Woolly Adelgid

The Mason-Lake Conservation District is seeking a Field Crew to carry out field survey and treatment work related to the invasive insect Hemlock Woolly Adelgid. This is a fast-paced job as part of a welcoming team in a beautiful area. This Early Detection and Response effort is an opportunity to make a major positive impact on forest health in Michigan. This project is funded by a grant through the Michigan Invasive Species Grant Program.

#### **Position Summary:**

Over the past several years, the invasive insect hemlock woolly adelgid (HWA) has been spreading northward along the west coast of Michigan. This project will be part of an existing, collaborative, effort, between federal, state and local agency partners, to detect and control HWA. Mason-Lake Conservation District is part of the North Country Cooperative Invasive Species Management Area (NCCISMA) which works to manage invasive species in western Michigan.

We are seeking self-directed, responsible, and highly motivated individuals with a positive attitude who can work successfully as part of a team. Individuals with the ability to communicate effectively with coworkers and the public, strong organizational skills, and a background in natural resources management or a related field are preferred. HWA identification and treatment training will be provided, but prior experience with invasive species work is advantageous. Routine handling of pesticides is a requirement of this position.

While working in the field, the Field Crew will be subject to inclement weather such as rain, snow, and extreme cold or heat and wind while doing physical work such as hiking for extended periods on uneven or slippery terrain while carrying up to 40 lbs of equipment. This includes walking up and down dunes, navigating through brush, where stinging insects or poisonous plants may be present.

### **Position Duties:**

- Conduct field-based surveys and mapping of hemlock woolly adelgid (HWA) in winter
- Conduct treatments of infested trees in summer using approved pesticides and specialized treatment equipment
- Assist the Project Manager in preparing landowner mailings and responding to visit requests
- Maintain and repair any equipment
- Enter survey and treatment data into Survey123, Google Sheets or similar program

### **Desired Qualifications:**

- Bachelor's degree (or significant progress towards such) in Biology, Forestry, Natural Resources or related field OR one year of related experience with invasive species treatments
- Ability to recognize and properly identify tree species and forest pests
- Michigan Pesticide applicator license (or willingness to obtain) in Core, forestry, right-of-way, and ornamental categories
- Ability to learn on the job and apply knowledge, such as reading and following pesticide labels
- Ability to communicate with the public on forest pest issues and project aspects
- Proficient in Microsoft Office suite (Excel, Word) and use of Google Sheets
- Experience with data entry and management
- Must have valid driver's license and clean driving record
- Able to collaborate well with others, follow instructions and works as a supportive team member
- Able to work in various field conditions
- Able to field navigate using online and printed parcel and aerial maps and plat maps
