Keynote speakers



Allan Bird is a Sr Professor at Goa Institute of Management. His research focuses on effective leadership and management at the intersections of culture in global contexts. Particular interests include the assessment and development of individual and organizational competencies and, more recently, diversity, inclusion and equity in intercultural interactions. Dr Bird's publications appear in *Journal of International Business Studies, Journal of World Business, International Business Review* and *Academy of Management Journal* (amongst others). He is a reviewing editor for the *Journal of*

International Business Studies. Since 2001, Dr Bird has also served as President of The Kozai Group, Inc., an international consulting firmed focused on identifying and developing exceptional talent.



Tine Köhler is Associate Professor for International Management at the University of Melbourne, Australia. Her main research interests include cross-cultural management, cross-cultural communication and coordination, group processes, qualitative research methods, research design, meta-analysis, and regression. Her work appears in *Organizational Research Methods (ORM), Journal of International Business Studies, Journal of Management, European Journal Work Organizational Psychology, Small Group Research (SGR), Academy of Management Learning and*

Education (AMLE), Industrial and Organizational Psychology, Psychological Methods and *International Journal of Human Resource Management* (amongst others). Dr Köhler is Co-Editor-in Chief at *ORM* and an instructor for the Consortium for the Advancement of Research Methods and Analysis (CARMA).

Indicative Schedule

DAY 1: We meet early on Thursday 24 November for the **Research Symposium**. This is a full day of research paper presentations, panel sessions, insights from our invited keynote speakers and dedicated mentoring for Women in Academy of International Business. We conclude with an early dinner, leaving plenty of time to enjoy the tropical evening of Brisbane.

DAY 2: We continue on Friday with small group **Paper Development Workshops** in which mentors and mentees are matched. We also plan interactive panels with Journal Editors and 'spotlights' on, for example, teaching IB, engagement and career development. We'll also hold the **Annual General Meeting**, with a presentation by Professor Peter Liesch on current initiatives and future directions of Academy of International Business.



Peter Liesch is Professor of International Business at the UQ Business School and President-elect for Academy of International Business. His research interests are in firm internationalization processes and international business operations in their entirety. Peter's work appears in the *Journal of International Business Studies, Academy of Management Journal, Journal of the Academy of Marketing Science, Journal of Management Studies, Journal of World Business, Management International*

Review, International Business Review, among others. He was awarded a Fiftieth Anniversary Silver Medal for publications in *JIBS*, 2019.
