Proceedings will be electronically published after the end of the Conference and will consist of papers, workshop descriptions and panel summaries PRESENTED at the Conference. Please submit your completed submissions for the Proceedings in the proper format by September 1, 2023.

Saint Joseph's University (SJU) is a private Jesuit university in Philadelphia that was founded by the Society of Jesus in 1851. It is one of 27 member institutions in the Association of Jesuit Colleges and Universities and the fourth largest university in Philadelphia and growing. Currently, it includes the 125-acre Hawk Hill campus and the 24-acre University City campus. On June 1, 2022, SJU acquired the University of the Sciences, adding professional programs in health and science, including occupational and physical therapy, physician assistant and the country's oldest and most prestigious pharmacy program, to its 135 undergrad and 77 graduate programs to include an Ed.D. in Educational Leadership and the Kinney Center for Autism Education and Support.
