# **CONFERENCE OVERVIEW**

Founded in 1917, Providence College is a primarily undergraduate Catholic and Dominican liberal arts higher education institution, ranked #1 by U.S. News & World Report in

the "Regional University – North" category. This year's host school, the AACSB-accredited Providence College School of Business (PCSB), is home to four undergraduate programs – accountancy, finance, management, and marketing – and two graduate programs – an MBA program and a master's in business analytics program. The PCSB's Undergraduate Program has placed in the Top 50 in the Poets & Quants' ranking for the last four years, climbing to #37 for 2023, and the PC MBA Program is ranked a Top 100 part-time program by U.S. News & World Report.

We welcome submissions in two formats – paper proposals and panel proposals. For paper proposals, please submit a 200-250 word abstract of your proposal for consideration at the conference. Abstracts of more than 250 words are not accepted into the submission system.

For panel proposals, please submit a brief (200-250 words) description of the panel along with the names of three to five panel members. Each panel session will last for 90 minutes and will consist of presentations by three to five delegates around the same topical area, followed by a Q&A between presenters and the audience. All panel members must attend the conference.

Please note, even though the system has an abstract box, you still need to upload your abstract as a PDF or WORD file as an attachment to complete the submission.

Further, you may submit a full-length paper for consideration for the conference awards and/or JIBS-JIBP joint PDW. After the proposal submission deadline, please email your paper to Dr. Juan Bu at <u>jbu@iu.edu</u> by **September 1, 2023,** for awards consideration, and/or, JIBS-JIBP paper development workshop (please specify).
